## description

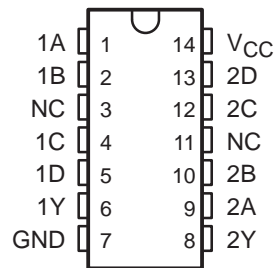
These devices contain two independent 4-input NAND gates. They perform the Boolean functions  $Y = A \cdot B \cdot C \cdot D$  or  $Y = \overline{A + B + C + D}$  in positive logic.

The SN54F20 is characterized for operation over the full military temperature range of  $-55^{\circ}\text{C}$  to  $125^{\circ}\text{C}$ . The SN74F20 is characterized for operation from  $0^{\circ}\text{C}$  to  $70^{\circ}\text{C}$ .

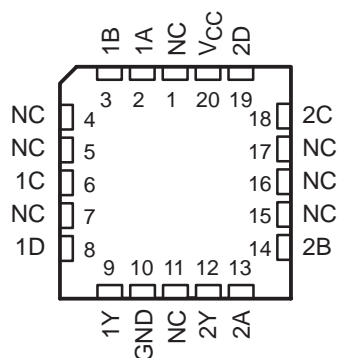

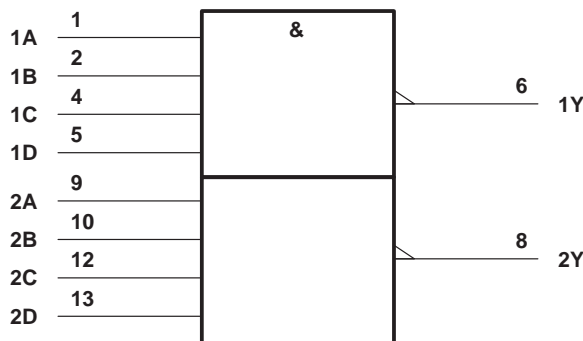


SN54F20 . . . FK PACKAGE  
(TOP VIEW)



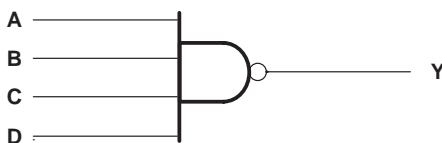



Designer will fully indemnify TI and its representatives against any damages, costs, losses, and/or liabilities arising out of Designer's non-compliance with the terms and provisions of this Notice.
